A **BILL**

entitled

An Act to appropriate the sum of three trillion, seven hundred eighty-eight billion, three hundred eighteen million, nine hundred fifty-seven thousand, nine hundred thirteen Kwacha to the goods and services of the financial year ending 31st March, 2024

ENACTED by the Parliament of Malaŵi as follows-

1. This Act may be cited as the Appropriation Act, 2023.

2. The Minister of Finance is hereby authorized, in the manner provided in the Public Finance Management Act, to direct payment out of the Consolidated Fund during the financial year ending 31st March, 2024, of sums not exceeding in the whole of three trillion, seven hundred eighty-eight billion, three hundred eighteen million, nine hundred fifty-seven thousand, nine hundred thirteen Kwacha to the goods and services of the financial year ending 31st March, 2024.

Short title

Expenditure of K3,788,318,9 57,913 authorized No. 4 of 2022 Appropriation **3.** The sum authorized in section 2, not exceeding in the whole, three trillion, seven hundred eighty-eight billion, three hundred eighteen million, nine hundred fifty-seven thousand, nine hundred thirteen Kwacha shall be appropriated for the purpose of expenditure out of the Consolidated Revenue and Capital Accounts, and each amount set out in the *Schedule* shall be appropriated to the Vote for the Head of Expenditure appearing opposite the amount.

Unused balance to lapse 4. Any balance of an amount set out in the *Schedule* which is unused at the end of the financial year ending 31st March, 2024, shall lapse and shall not be available for making payments in any subsequent months.
