APPROPRIATION (AMENDMENT) BILL, 2024

MEMORANDUM

This Bill seeks to amend the Appropriation Act, 2024, by increasing the amount appropriated under the Act, from five trillion, nine hundred ninety-eight billion, eight hundred thirty-three million, six hundred fifty-nine thousand, nine hundred twenty-two Kwacha to six trillion, forty billion, three hundred seventy-three million and forty-eight thousand, one hundred seventy-two Kwacha; and replacing the Schedule to the Act with a new Schedule in order to change the amounts appropriated on respective Votes for the financial year ending 31st March, 2025. The allocations in the Schedule have been revised on Vote by Vote basis to accommodate implementation dynamics that occurred in the course of implementing the 2024/2025 budget. Following enactment of this Bill, the approved expenditure for the financial year 2024/2025 will be increased by forty-one billion, five hundred thirty-nine million, three hundred eighty-eight thousand, two hundred and fifty Kwacha.

Short title	1. This Act may be cited as the Appropriation (Amendment) Act, 2024.	
Amendment of long title to Act No.7 of 2024	2. The Appropriation Act, 2024 (hereinafter referred to as the "principal Act") is amended, in the long title, by deleting the words "five trillion, nine hundred ninety-eight billion, eight hundred thirty-three million, six hundred fifty-nine thousand, nine hundred twenty-two Kwacha" and substituting therefor the words "six trillion, forty billion, three hundred seventy-three million and forty-eight thousand, one hundred seventy-two Kwacha".	
Substitution of s.2 of the principal Act	3. The principal Act is amended by deleting section 2 and substituting therefor a new section as follows—	
	"Expenditure of K6,040,373,048,172 authorized No. of 2024	2. The Minister of Finance is hereby authorized, in the manner provided in the Public Finance Management Act, to direct payment out of the Consolidated Fund, during the financial year ending 31st March, 2025, of sums not exceeding in the whole of six trillion, forty billion, three hundred seventy-three million and forty-eight thousand, one hundred seventy-two Kwacha to the goods and services of the financial year ending 31st March, 2025.".

4. Section 3 of the principal Act is amended by deleting words "five trillion, of s.3 of the nine hundred ninety-eight billion, eight hundred thirty-three million, six principal Act hundred fifty-nine thousand, nine hundred twenty-two" and substituting therefore the words "six trillion, forty billion, three hundred seventy-three million and forty-eight thousand, one hundred seventy-two Kwacha".
